Applicants will be evaluated on involvement and leadership in dairy-related activities, scholastic achievement and career objectives. Apply for a Scholarship

The Wisconsin 4-H Foundation will award more than \$15,000 in scholarships to outstanding Wisconsin students pursuing higher education in 2020. To be considered for financial support, applications must be received by the Wisconsin 4-H Foundation via email by Monday, March 16, 2020, 5:00 pm.

Wisconsin 4-H Foundation scholarships are awarded to students based on demonstrated personal growth, development and leadership, academic performance and future educational goals.

To be eligible for Wisconsin 4-H Foundation scholarships students must have been a Wisconsin 4-H member for at least three years; have a grade point average of at least 2.5 on a 4.0 scale, and be enrolled or planning to enroll at a university, college or technical school during the 2020-2021 academic school year. Tractor Safety & Certification-March 2020

Does your son or daughter work on a farm during the summer? Do you hire youth to work for you during the year? Do these young people have adequate safety training?

To help reduce accidents, a Farm Tractor Safety Certification Course is being coordinated by UW-Extension Washington, Ozaukee, Sheboygan, & Fond du Lac Counties. The 24 hour course will be held on the following **Saturdays – March 14, 21, and 28 and April 4** from **9:00 a.m. to 3:00 p.m**. March 14 and 21 will be held at Campbellsport High School and March 28 and April 4 will be held at Allenton Town Hall. The course focuses on the safety aspects of operating farm equipment. To complete the course, youth must attend all four sessions and pass a written and driving exam.

The course includes classroom safety instruction for tractors and farm machinery operation, hazard recognition and correction, general farm safety knowledge, and how to approach farm safety with a positive attitude. In addition, the course is designed for youth ages 14-15 who need the federal certificate of training for employment on farms, youth ages 12-16 who will be operating tractors or self-propelled farm machinery on public roads for their own family, and youths interested in tractor and machinery safety. Youth must be the **minimum age of 12** in order to register.

Youth who drive a tractor for their parents may still do so without the formal training program as long as they do not operate the tractor on a public road.

If you intend to hire youth on your farm, make sure that they enroll in this course for your protection as well as theirs.

The cost of the course is **\$40 per student** and is **limited to the first 25 paid participants.**

In the Spotlight

Attending 4-H Congress

Over Thanksgiving weekend, I had the opportunity to attend the 99th annual National 4-H Congress. I traveled with 39 young leaders from around the state of Wisconsin and had the opportunity to engage with delegates from 43 states and the territory of Puerto Rico. Through this experience, I was able to strengthen my leadership skills, as well as observe the cultural diversity that Atlanta has to offer.

We arrived at the Hartsfield-Jackson Atlanta International Airport on Friday and used the MARTA, Atlanta's version of the subway, to travel to our hotel and conference center. Our state picture was taken at Centennial Olympic Park, which is where the 1996 Summer Olympics were held. I had the opportunity to explore the city before the opening ceremony began. Our first speaker was John Beede, a youth motivational speaker that had the goal of climbing the tallest mountain on each continent. He talked about setting "Everest-sized" goals for ourselves and how we can achieve them. We then participated in a "get acquainted" activity that focused on meeting delegates from around the country. This activity showed us that even though we live drastically different lives, we all have something in common.

The next morning I attended the opening ceremony. Our speaker for the day was the honorable Sonny Perdue who is the United States Secretary of Agriculture. He focused on telling us to not be complacent and to take charge of our future. I then attended MEGA workshops that focused on meeting new people, community service, and becoming a better person. That night, we attended the International Dinner and Dance, where we ate food from around the world and watched cultural dances from Hawaii and Puerto Rico. We ended the night with the first 4-H dance.

The following day I attended the flag ceremony where the flag from each state was presented. We then listened to the speaker Manny Ohonme from Africa. He received his first pair of shoes from winning a game of basketball when a group of missionaries was visiting. Manny focused on playing basketball and he later received a scholarship to play basketball in North Dakota. He then started Samaritans Feet, an organization that focuses on giving shoes to people in Africa. We then had a traditional Southern lunch at Pittypat's Porch. That afternoon I attended a Pilates workshop and the Coolness of Science workshop. That night we went to the Atlanta History Center where we learned about the history of Atlanta. On the third day of the National 4-H Congress, my group volunteered at a local 4-H center by helping clean the area. That afternoon I attended a tour of CNN and learned much about how the media is operated, from the video equipment to televising the information. That night the Congress Gala was held. Our first speaker was Kelly Loeffler, an Illinois 4-H alumni member. She is the CEO of a financial company and the co-owner of the women's basketball team, the Atlanta Dream. She will also be serving as a senator for Georgia in 2020. We also heard from Dr. Scott Angle, the Director of the National Institute of Food and Agriculture and along with Brenda Reid, the manager of Media and Community Relations for PUBLIX, a grocery company that focuses on giving back to the community. We then attended the Congress Dance and held a State meeting where we reviewed on our day.

On the final day of National 4-H Congress. The closing assembly was held and our closing speaker was Dan Clark. Dan Clark played football in college and was faced with an injury that paralyzed him, but later became a successful businessman. In 2001, he was named one of the "Top Ten Best Speakers in the World." I learned so much and enjoyed Dan's speech very much. Dan has also been the closing speaker at National 4-H Congress for the past 25 years, and he said that he fully enjoys talking to the National 4-H Congress delegates from around the country. We left Atlanta that afternoon to head back home to Milwaukee.

I have had the opportunity to attend three different experiences with 4-H. One of these experiences was a statewide activity, and the other two were National activities, where I was able to interact with 4-H delegates from around the country. I would like to say a special thank you to the Fond du Lac County Adult Leaders Association for partially sponsoring my experiences. Through each of these experiences, I was exposed to many leadership opportunities and I grew in my communication and teamwork skills. The memories that I have made on these experiences are ones that I will cherish forever.

4-H Policies

The current Fond du Lac County 4-H policies on membership and achievement are listed below. They are also found in the enrollment booklet and on our website.

FOND DU LAC COUNTY 4-H POLICY ON MEMBERSHIP

1. Youth wishing to join Fond du Lac County 4-H must be enrolled in kindergarten (and be at least five years old by October 1, 2019) through one year after high school graduation and not to extend beyond the age of 19 as of December 31 of the enrollment year. Youth in grades K-2 enroll in the Cloverbud project.

2. Re-enrollment period is until October 31. New member enrollments will be accepted until Jan. 31, 2020. Members not enrolled by the appropriate date will not be eligible to exhibit for a premium at the 2020 Fond du Lac County Fair. However, they will be able to participate in other club and county events. Memberships must be accepted all year long.

3. Dropping a project must be done in writing by the first Friday in April. Projects may not be added after the enrollment deadline.

4. Policy on re-enrollment of non-achievement members is left to the local club.

5. It is recommended that younger members take one project only, and a maximum of five projects be taken by older members.

6. A member should satisfactorily complete all projects carried in order to be an achievement member. (See Fond du Lac County 4-H Achievement Policy)

7. Members qualify for full graduation honors upon completion of high school, though they have the option to

remain in 4-H one year past high school graduation.

8. A member is to enroll in one 4-H club during the enrollment year.

FOND DU LAC COUNTY 4-H ACHIEVEMENT POLICY

Fond du Lac County 4-H strives to provide a positive experience to the youth members who join. "Achievement" within the program plays a fundamental role in order for young people to obtain the most beneficial 4-H experience.

Youth members must enroll in at least one 4-H project.

Youth members are expected to complete all 4-H projects enrolled in for the year. Youth members should be aware of the county deadline for dropping projects.

Re-enrolling members must achieve in all projects the previous 4-H year. Members who do not achieve in the previous year may have their membership role limited the next year i.e. not be able to hold a club office or be allowed to take any more than 2 projects.

Youth members must publicly exhibit (such as Alto Fair, county fair, etc.) at least one exhibit in every project enrolled in. Legitimate reasons for not exhibiting at a fair event should be corresponded with your club's General Leader so that alternate accommodations may occur - examples include club or project meetings.

Youth members should complete and submit to their 4-H club a Record Book. This Record Book should be completed to the best of the member's ability, with proper forms completed for each project enrolled in.

Cloverbuds (members in grades K - 2) should complete a Cloverbud scrapbook. Turn it in to the club general leader who will provide feedback. Cloverbuds are not eligible for any county awards.

Youth members must fulfill attendance requirements as established at the club level. Every effort should be made to be an active member of the club in order to be considered for county and state level events. If active membership is a hardship you are encouraged to communicate with club leaders.

Upon the first year of achievement the member (including Cloverbuds) will receive a nameplate and disc. In following years, a disc is earned for each year of achievement.

What is the Discretionary Fund?

The budget of the Fond du Lac County 4-H Leaders Association includes a discretionary fund. The purpose is to aid members who may have limited financial resources to participate in 4-H programs. If you need to access funds, please contact Tracy Keifenheim at the Extension Office.

4-H Emblem Guidelines

The 4-H Name and Emblem is a highly valued mark within our country's history. Therefore, the 4-H Clover has been granted federal protection noted by the 18USC707 on the lower right of the clover. Because of this status, **there are specific guidelines for using the 4-H name and emblem**. If you are a chartered 4-H entity, you have the right to use the clover emblem. There is no fee or paperwork to be completed. If your club or committee will be using the clover on printed items, contact the Extension Office for guidelines or refer to this document https://nifa.usda.gov/sites/default/files/resource/4-H%20Name%20and%20Emblem%20User%20Guide%202014.pdf (pages 10-13).

4-H Members Have Accident Policy Coverage

Each member is covered by accident insurance when participating in an approved and adult supervised group activity. It does not cover injuries sustained while skiing, tobogganing, sledding or tubing. Clubs are billed for this insurance annually. The American Income Life 4-H annual group accident policy covers individual 4-H clubs and country wide programs.

Plan Highlights:

- Includes incurred medical and surgical treatment, Xrays, hospital confinement, and ambulance expense up to the maximum amount
- Covers dental services incurred within 52 weeks of the accident

- Provides a benefit if death occurs as a result of an accident within 100 days of the accident
- Covers loss of limbs up to a set amount
- Optional volunteer leader coverage available. Clubs pay for this coverage if requested.

If a member is injured a claim form needs to be completed. The form is available at <u>https://www.ailife.com/Pdfs/documents/</u> <u>Special-Risk-Claim-Form.pdf</u>. The form may also be accessed on the 4-H website by looking under *Resources*, then under *Club Leadership*. Additionally, the adult in charge of the event should contact Tracy at the Extension office to get the form processed once it is filled in. Injuries should be reported promptly.

Insurance for 4-H Leaders

Fond du Lac County 4-H leaders are covered by a liability insurance policy. They are automatically covered under this policy if they are a registered 4-H leader, completed the youth protection process and are acting within the scope of their volunteer role. This policy is a secondary for personal liability coverage.
