#### WHEN AND HOW CAN OUR CLUBS AND PROJECTS MEET?

Many of you have heard that in order to hold any in-person 4-H project meetings, committee meetings, officer meetings, club meetings, roadside clean-ups etc. that approval must be given by Extension. All clubs/groups/committees must follow the new guidelines that have been developed. I am including the new process below. You are also welcome to email me if you have any questions! Many clubs/groups have already started meeting with approved meetings and activities. Activities or meetings that have been approved include: a mini golf outing, club meetings in parks, etc. I am working with a few additional clubs/groups for more in person meetings/activities.

**Step 1:** Watch the training video: <a href="https://fyi.extension.wisc.edu/covid19/video/">https://fyi.extension.wisc.edu/covid19/video/</a>. This video will go over details about Covid-19 and some guidelines. It is about 20 minutes and will make filling out the proposal form much easier. This video must be viewed (training must be completed) by key leaders involved in the programs' proposal prior to the program being held.

**Step 2:** After watching the video, complete this <u>short quiz/form</u> to confirm your participation. This will serve as an official record of volunteers who completed a "safety training." The link to the quiz is here <a href="https://forms.gle/vi6GU7q8e4bbVPX67">https://forms.gle/vi6GU7q8e4bbVPX67</a> and is only three questions.

**Step 3:** Call or email me for the form to fill out. You can fill it out and send it to me, or we can work together. The form asks questions about the activity, personal protection equipment, distancing, facility, food, etc. After the form is approved, you can move forward with the meeting/event/activity. There is a short follow up to be submitted after the program.

\*More than one group (each under 10 individuals) may meet in outdoor or multi-room locations where the groups can remain separated and physically distanced.

- Groups may use separate spaces in the same venue such as a school, library, or community center where groups remain in different rooms and physically distant throughout the event
- Groups may use several areas within a park or other large outdoor space.
- \*Total numbers across all groups may not exceed 50 individuals.
- \*There must be a minimum of 20 feet between each group of 10 when outdoors.
- \*Each group must have its own staff/adult leader. Groups must remain together, staff/volunteers and youth cannot rotate between groups during a meeting or activity.
- \*Plans will include how young people will access the unique spaces without congregating, including parking, drop-off and pick-ups.
- \*When making plans for outdoor gatherings it is important to have a back-up plan in case of bad weather.

Thank you for your patience and cooperation as we all work through this together!

Attendance will be tracked for the requirement of annual leader training on Wisconsin 4-H Club Charters. In order to meet the requirement, **one leader from each club or group MUST attend at least one** of the hourlong sessions.

Did you know that there needs to be <u>at least one</u> <u>enrolled adult leader</u> present for every ten youth at EVERY 4-H event? Adults only count in the ratio, if they have completed the four steps to becoming an <u>enrolled leader</u> (pass a national background check, enroll in 4HOnline, complete the online mandated reporter training, and attend an in-person Volunteer in Preparation Training). Please encourage all parents in your club
